Other areas include implementing programs that assist rural dwellers with managing existing disease at home to prevent disease exacerbation and hospitalization and exploring factors related to disease risk and exacerbation among rural populations.

This program of research involves understanding factors associated with rural health and developing and testing evidence-based interventions that facilitate increased chronic disease awareness, enhanced knowledge, and promotion of healthy lifestyle behaviors and skills to help people learn how to stay well, reduce modifiable disease risk factors, and avoid hospitalization and disease exacerbation. This also involves exploring factors related to disease risk and disparities among rural groups including stress and protective factors such as social support and resilience.
