Program of Research and/or Focus of Original Creative Work

My research program studies the developmental origins of childhood obesity with a particular focus on infant feeding practices and infant weight gain. Specifically, my research examines maternal decisions regarding infant feeding practices and factors that influence those decisions, prenatal infant feeding plans and deviations from those plans, and contributors to infant growth. My colleagues and I have developed a responsive infant feeding intervention, Learning Early Infant Feeding Cues (LEIFc) and are testing the feasibility and fidelity of the intervention in mother-infant dyads. I am also examining research priorities during the 4th trimester (birth to 3 months).
